I am the above named person and I live at the address given with my husband. I am one of the great granddaughters of Thomas Henry Smith. He lived at Sinky Bay in Southampton. My great grandfather owned land in Southampton, 19 acres, from Cross's Bay all up the hill by Princess Hotel.

My mother also told me that one day Vivian Wilson came to her house up Gibbs Hill. She was living in the Government Assistant House known as the poor house, Vivian was a relative. She was a nephew of my great grandfather and he told my grandmother that he had come to the house to give her a hundred pounds. That was all that her father had left her. She could not believe it. She cried about it and I think she died of a broken heart.

In 2005, I went to the Government Archives with my cousin Juanita Campbell and my aunt Edith Darrell. We found the will of Thomas Henry Smith. When we saw the will we became concerned when we saw the named Thomas Smith signed on the last page of the will. The reason for our concern is that we knew that it was a known fault among our family members that my great grandfather could not read or write.

We were also concerned that he left my grandmother one hundred pounds and gave his land to Vivivan Wilson for his use and benefit. My aunts, four of them and my mother got nothing.

After this we had a letter written for the family of Vivian Wilson. In that we told his family what he had done to get land that really should have been ours. One of Vivian's daughters said to us that she did not know anything about it. This did not go any further until I met Walton Brown. Walton came up Daniels Head where I had a concession. I used to sell drinks and snacks. We discussed land grabs and this is why I wrote to the commission and I wanted to get some justice for my grandmother.

Vivian Wilson's family benefited from getting my great grandfather's property in making this submission. I am representing my grandmother and three surviving aunts and my mother. The Government should write to the Queen for compensation.
