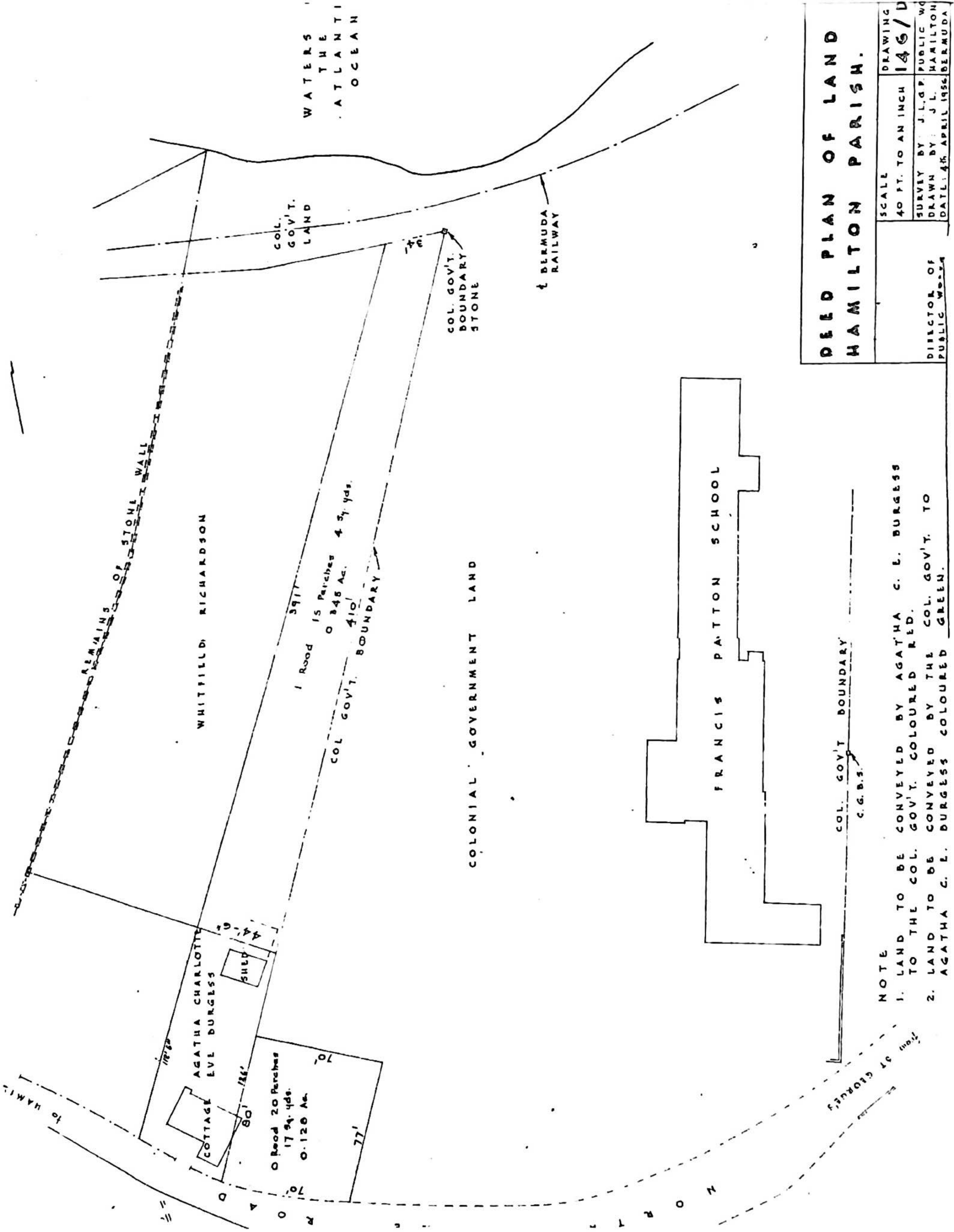

WHEREAS it is agreed between the GOVERNMENT of BERMUDA and AGATHA CHARLOTTE EVE BURGESS of Hamilton Parish in the Islands of Bermuda that Agatha Charlotte Eve Burgess shall grant and release unto Her Majesty Her heirs and successors the strip of land delineated and coloured red on drawing No. 146/D/2 prepared by the Public Works Department of Bermuda and dated the 4th April 1956 (a copy of which drawing is hereunto annexed) and that in consideration of the said grant that the Government of Bermuda shall pay to the said Agatha Charlotte Eve Burgess the sum of one thousand pounds and shall grant and release the lot of land delineated and coloured green on the drawing aforesaid unto and to the use of the said Agatha Charlotte Eve Burgess NOW for the purpose of giving effect to the said agreement I Agatha Charlotte Eve Burgess in consideration of the sum of one thousand pounds paid to me by the Government of Bermuda and of the grant hereinafter mentioned do hereby grant and release unto Her Majesty Her heirs and successors ALL THAT strip of land delineated and coloured red on the drawing aforesaid TOGETHER WITH all rights and appurtenances thereto belonging and all such estate right title and interest in and to the same as I am or shall become seized or possessed of or am by any Act or law empowered to
