## A Description of the EXHIBITS TO BE USED AS EVIDENCE

- Exhibit (A) Shows Robert Motyer's signature on the drafting of the Last Will s and Testament of John Augustus Alexander Virgil where he was to protect the wishes of Augustus Virgil and provide legal advice to Virgil in connection with the drafting of the Will. Further, Virgil appointed Bank of Butterfield Executor and Trustee Co. Ltd as the Sole Executor.
- 2. **Exhibit (B)** In Appleby's prepared report for Butterfield in 1978 it used the strength of John Alfred Virgil's deeds the imposter as we still have in our possession the original title deeds from 1885 to 1945 when the mortgage was paid.
