81 through 83 and thereby appointing Shirley Richardson my Power of Attorney and DO
NOW APPOINT the said ALBERTHA HARRIS and CAROL-ANN LOUISE FURBERT
my true and lawful attorneys for me and in my name to do the following acts and things or any
of them that is to say:

1. To demand sue for enforce payment of receive and give discharges for all monies securities for monies debts stocks shares and other personal property now belonging or hereafter to belong to me whether solely or jointly with any other person or persons;
2. To manage my business affairs investments securities and personal property for the time being in such manner as my attorneys shall think fit and to make any payments in connection with my business affairs investments securities and personal property;
3. To commence carry on or defend all actions and other proceedings touching my property(ies) or affairs or any part thereof or touching anything in which I or my property(ies) or affairs may be in anywise concerned;
4. To settle compromise or submit to arbitration all accounts claims and disputes between me and any other person or persons;
